Following the resolution of the Faculty Council of the Faculty of Social Sciences on 30.06.2021 the Presidential Board of the Georg-August-Universität Göttingen on 10.08.2021 approved the seventh amendment of the regulations about the charging of fees for the Master's degree programme "Euroculture" in the version of the announcement on 16.12.2004 (Official Announcements no. 12 p. 841), last amended by resolution of the Presidential Board on 29.05.2018 (Official Announcements I no. 25/2018 p. 483) (§ 13 section 3 sentence, 9 sentence 1 NHG (Lower Saxony Higher Education Act) in the version of the announcement of 26.02.2007 (Nds. GVBI. (Lower Saxony Law and Official Gazette) p. 69), last amended by Article 4 of the Act on 16.03.2021 (Nds. GVBI. (Lower Saxony Law and Official Gazette) p. 133)).

§ 1 Charging, scope

(1) The Georg-August-Universität Göttingen charges fees in the sense of § 13 section 3 NHG to students who are enrolled or re-registered for the Master's degree programme "Euroculture".
 (2) ¹The Georg-August-Universität Göttingen shall not be liable for additional costs incurred by the participants in connection with the procurement of working materials, excursions, etc. as a result of the advanced study programme. ²These additional costs are not covered by the fees.
 (3) The levying of further fees and charges on the basis of other legal provisions shall remain unaffected.

§ 2 Amount of fees, due date, calculation principles

(1) ¹The fee according to these regulations is 1,475 euros per study semester. ²Excepted from

this are students who are on leave of absence for an entire semester or who are completing a period of study abroad as provided for in the examination or study regulations.

(2) In deviation from section 1, foreign or stateless students who are not considered equal to Germans according to § 7 of the Lower Saxony Ordinance on the Allocation of Study Places by Institutions of Higher Education (Hochschul-VergabeVO) of June 22, 2005 (Nds. GVBI. p. 213), as amended, shall be charged fees in the amount of 4,500 euros per semester of study.
(3) Notwithstanding section 1, fees shall not be charged to students enrolled under an intergovernmental or supranational agreement, to the extent that reciprocity exists and to the extent that the charging of fees is excluded under such agreement.

(4) ¹Fees are due for the first time upon enrollment and then each time upon expiration of the re-registration period. ²If the application for enrollment is rejected, any fees paid shall be refunded. ³The deadlines for re-registration are specified in the enrollment regulations. ⁴Enrollment or re-registration without payment of the due fees is excluded.

(5) Fees shall be collected by the general university administration.

§ 3 Fee debtor

The person liable to pay the fee shall be the person who incurs the charge within the meaning of § 1 section 1.

§ 4 Final provisions

(1) The fees shall be charged for the first time as of the winter semester 2013/2014.

(2) This regulations about the charging of fees shall enter into force on the day following its publication in the Official Announcements of the Georg-August-Universität Göttingen.

§ 5 Transitional Regulations

For students who began their studies prior to the entry into force of the amendment to these regulations and were continuously enrolled in this degree programme, the regulations about the charging of fees shall apply in the version in effect at the time of enrollment.
